GENERAL GUIDANCE

1. When should this form be used?

This form should be used if you are applying for a visa or entry certificate to settle on Pitcairn Island, that is, if you wish to live there permanently. The different categories under which you can apply are listed on the front of the form. Please note: if you wish to apply as a Returning Resident, you should use the non-settlement application form.

2. Completing the form

Please answer all the questions as indicated. The form is designed to help determine whether applicants meet the requirements of the Pitcairn Immigration Rules, and to assist applicants in demonstrating that they meet those requirements. If you do not understand any of the questions, or require additional guidance, please contact the Pitcairn Island Office admin@pitcairn.gov.pn. We will only reply to questions relating to this form, we will not engage in correspondence about the Pitcairn lifestyle etc. There is a wealth of information on www.immigration.gov.pn and other Pitcairn related websites.

3. What documents should I provide?

In completing the application and providing documents, you will need to demonstrate that you meet the requirements of the Pitcairn immigration rules.

Specific advice about the rules for each category can be obtained from the Pitcairn Island Office admin@pitcairn.gov.pn

All applicants must provide:

- The appropriate fee. Without the fee we will not enter into correspondence on individual settlement applications.
- A scanned copy of a valid passport photo page.
- Evidence to substantiate information given, including financial information, sponsor's income (in you have a sponsor) and proof of assets.
